## Painterly brushes artwork contest: Official rules

Submit original CoreIDRAW artworks comprised of Painterly brushstrokes to Corel Corporation ("Corel") that best meet the winning Artwork criteria to enter to win a $\$ 1,000$ USD gift card (or equivalent local currency value). ("Contest")

## Contest Period:

- Contest begins on April 29, 2024 and ends on May 29, 2024 at 11:59 p.m. EDT


## How to Enter:

- Contest entrants are permitted to enter the contest as many times as they wish.
- Contest entrants are limited to five (5) pieces of Artwork ("Artwork") per submission.
- Each individual piece of Artwork will be considered as 1 (one) entry.
- Artwork must be created using CoreIDRAW 2024*.
- Each submission must be an original piece of Artwork, created with the incorporation of the Painterly Brush tool.
- Entrants must provide their full name and email address and acknowledge their acceptance of these official rules for participating in this contest at the end of the contest submission form.
- Artwork must be the contest entrant's own unique and original creation designed using CoreIDRAW 2024.
- Any number of Painterly brushes may be used in the Artwork, but a minimum of one (1) Painterly brush must be included in each piece of Artwork to be eligible to enter.
- All vector objects that make up the Artwork must be entrants original creation.
- Any fonts or stock graphics used within the Artwork must be licensed by the contest entrant.
- Artwork submissions must be exported from CorelDRAW 2024 and uploaded as a PNG or JPG file.
- Submission of artwork confirms entrant's consent to Corel to use such artwork and entrant's name for any marketing and/or promotional purposes in any media now known, regardless if entrant is declared the winner.
- Void where prohibited by law.
