

## 2025 Annual artwork callout contest: Official rules

Submit original CorelDRAW artwork to Corel Corporation (“Corel”) that best meet the winning Artwork criteria to enter to win a \$500 USD gift card (or equivalent local currency value). (“Contest”)

### Contest Period:

- Contest begins on September 2, 2025 and ends on September 14, 2025 at 11:59 p.m. EDT

### How to Enter:

- Contest Participants (“Participants”) are limited to five (5) pieces of Artwork (“Artwork”) per entry form submission. However, Participants may submit the entry form as many times as they wish.
  - Each individual piece of Artwork submitted will be considered as 1 (one) entry.
  - Speed drawing videos may be submitted as part of an entry, but the video must be accompanied by the final artwork depicted in the video.
  - Artwork must be created using a CorelDRAW product, including CorelDRAW Graphics Suite, CorelDRAW Standard, CorelDRAW Essentials, CorelDRAW Technical Suite, and CorelDRAW Go.
  - Each submission must be an original piece of Artwork.
  - Participants must provide their full name and email address and acknowledge their acceptance of these official rules for participating in this contest at the end of the [contest submission form](#).
  - Artwork must be the contest Participants own unique and original creation designed using CorelDRAW.
  - Participants may not submit Artwork on behalf of another person.
  - All vector objects that make up the Artwork must be Participants original creation.
  - Any fonts or stock graphics used within the Artwork must be licensed by the contest Participant.
  - Submissions which depict minor children, must be age-appropriate and non-exploitative. Any submission depicting minor children will require a Release and will be reviewed under strict guidelines.
  - Artwork submissions must be exported from CorelDRAW and uploaded as a PNG or JPG file for judging. **The Winner will only receive their prize upon providing the original .CDR file for verification.**

- Submission of artwork confirms Participant’s consent to Corel and its affiliated companies to use such artwork and Participant’s name for any marketing and/or

promotional purposes in any media now known, regardless if Participant is declared the winner.

- Participant must be the age of majority in their jurisdiction in order to participate in the Contest.
- Employees of Corel and its affiliated companies or members of their family are not eligible to participate.
- Void where prohibited by law.

#### **Prize:**

- The prize is a \$500 USD gift card (or equivalent local currency value).
- No cash or other prize substitution is permitted.
- The prize is nontransferable.
- Odds of being selected to win the Prize depend on the total number of eligible participants received during the Contest period.

#### **Winner Selection:**

- Judging will be conducted by Corel and one winner will be selected based on the [Winning Artwork criteria](#). No purchase necessary.
- The winner will be informed by email no later than September 22, 2025.
- The winner will be required to confirm receipt of the email and claim their prize within fourteen (14) days after the email has been sent. If no reply is received, the Corel reserves the right to select a new winner.
- If an Artwork contains any depiction of a recognizable person, and/or known image restrictions, Corel will require a Release granting the Participant the rights to use the image in order to be selected as winner.
- If an Artwork contains licensed third-party fonts and/or stock photos, Participant may be required to submit a copy of such license in order to claim the prize.

#### **Privacy / Use of Personal Information**

- By participating in the contest, the Participant : (i) grants to Corel the right to use their entry information ("Personal Information") for the purpose of administering the Contest, including but not limited to contacting and announcing the winner via email and Corel social media platforms, and (ii) acknowledges that Corel may disclose Personal Information to third-party agents and service providers in connection to provision of the prize and/or in connection with the activities listed in (i) above.
- The Contest winner understands they may need to provide Personal Information and/or set up an account with a third-party provider in order to receive their prize.



- Corel will use the Participant's Personal Information only for identified purposes and announcement of the Contest winner and shall be subject to Corel's privacy policy at <https://www.corel.com/en/corel-privacy-policy/>.
- Corel may use the Participant's Personal Information to contact them for additional information regarding their submission including but not limited requesting CDR files of their submission.

## **Termination**

Corel reserves the right, in its sole discretion, to terminate the Contest, in whole or in part, and/or modify, amend or suspend the Contest, and/or the Contest Rules in any way, at any time, for any reason without prior notice.
